> Re: <u>Civil Rights Complaint Against The University of Rhode Island</u> Regarding Discriminatory Scholarship Programs

To Whom It May Concern:

This is a federal civil rights complaint pursuant to the U.S. Department of Education's Office for Civil Rights ("OCR") discrimination complaint resolution procedures. We write on behalf of the Equal Protection Project of the Legal Insurrection Foundation, a non-profit that, among other things, seeks to ensure equal protection under the law and non-discrimination by the government, and that opposes racial discrimination in any form.

We bring this civil rights complaint against the University of Rhode Island ("URI") for offering, promoting and administering fifty-one (51) student scholarships that discriminate based on race and/or sex. The discrimination is so pervasive and systematic that urgent action by OCR is needed before the scholarships come up for reapplication in the spring 2025 semester.



These scholarships are listed, promoted and administered through the URI online scholarship system, and applications for them can only be accessed by logging in to the URI online scholarship system,² as reflected in the screenshot below from the URI website.³

"To apply to scholarships, you must first **Sign In** at the top right corner of this page with your URI Single Sign On credentials to access the campus login portal." [emphasis in original]







According to the FAQ for the URI online scholarship system, the system provides information on scholarships available to URI students, allows URI students to apply for scholarships, recommends scholarships for them, and matches them with scholarships for which they qualify.⁴

Moreover, as set forth below, many of the scholarships state that URI's Enrollment Services – a department of URI that assists students with their enrollment needs, "from understanding financial aid and registering for courses to paying [their] bill and getting a transcript" – selects the award recipients along with other URI staff members or faculty. URI thus is involved not only in promotion and administration of the scholarships, it selects the recipients.

The scholarships listed below were offered during the 2024-2025 academic year according to the URI website and violate Title VI of the Civil Rights Act of 1964 ("Title VI") and its implementing regulations⁶ by illegally excluding students based on their race and skin color, Title IX of the Education Amendments of 1972 ("Title IX") and its implementing regulations⁷ by excluding students based on their race, sex, or both. Because URI is a public university, these discriminatory scholarships also violate the Equal Protection Clause of the Fourteenth Amendment of the U.S. Constitution.

Each of the scholarships listed below had a June 30, 2024, application deadline for the 2024-2025 academic year, and some or all of them will come up for reapplication during the spring 2025 semester.

If such an award would not otherwise comply with applicable law, then the scholarship shall go to a student with demonstrated financial need and in good standing from a historically underrepresented population at the University."

The Scholarships Listed Above Violate The Law

Those scholarships identified above that discriminate on the basis of race, skin color or national origin violate Title VI, while those that discriminate on the basis of sex violate Title IX, and those that discriminate on both grounds violate both Title VI and Title IX. And, because URI

is a public university, such discrimination also violates the Equal Protection Clause of the Fourteenth Amendment. ¹⁰

Title VI prohibits intentional discrimination on the basis of race, color or national origin in any "program or activity" that receives federal financial assistance. See 42 U.S.C. § 2000d. Likewise, Title IX makes it unlawful for any to discriminate on the basis of sex in education. That statute provides that "[n]o person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance." 20 U.S.C. §1681(a).

The term "program or activity" means "all of the operations of ... a department, agency, special purpose district, or other instrumentality of a State or of a local government" and each state government agency "to which the assistance is extended." 42 U.S.C. § 2000d-4a(1)(A), (B). It does not matter that a particular program may be considered "extracurricular" or just a "club" or

"group," the same considerations apply, as OCR noted in its 2023 Guidance on Race and School Programming. ¹¹ As URI receives federal funds, ¹² it is subject to both Title VI and Title IX.

While the use of racial, skin color, and sex-based barriers described above are explicit, such descriptions also are "signaling" racial- and sex-based preferences. See Ragin v. New York Times Co., 923 F.2d 995, 999–1000 (2d Cir. 1991) (Fair Housing Act prohibits all housing advertisements that indicate racial preference to ordinary reader; "Ordinary readers may reasonably infer a racial message from advertisements that are more subtle than the hypothetical swastika or burning cross, and we read the word 'preference' to describe any ad that would discourage an ordinary reader of a particular race from answering it").

Regardless of URI's reasons for offering, promoting, and administering such discriminatory scholarships, URI is violating Title VI and Title IX by doing so. It does not matter if the recipient of federal funding discriminates in order to advance a benign "intention" or "motivation." *Bostock v. Clayton Cnty.*, 590 U.S. 644, 661 (2020) ("Intentionally burning down a neighbor's house is arson, even if the perpetrator's ultimate intention (or motivation) is only to improve the view."); *accord Automobile Workers v. Johnson Controls, Inc.*, 499 U. S. 187, 199 (1991) ("the absence of a malevolent motive does not convert a facially discriminatory policy into a neutral policy with a discriminatory effect" or "alter [its] intentionally discriminatory character"). "Nor does it matter if the recipient discriminates against an individual member of a protected class with the idea that doing so might favor the interests of that class as a whole or otherwise promote equality at the group level." *Students for Fair Admissions v. President & Fellows of Harvard College*, 600 U.S. 181, 289 (2023) (Gorsuch, J., concurring).

As URI is a public university, its offering, promoting, and administrating these discriminatory scholarships also violates the Equal Protection Clause of the Fourteenth Amendment. In *Students for Fair Admissions*, the Supreme Court declared that "[e]liminating racial discrimination means eliminating all of it The guarantee of equal protection cannot mean one thing when applied to one individual and something else when applied to a person of another color. If both are not accorded the same protection, then it is not equal." *Id.* at 206 (cleaned up). "Distinctions between citizens solely because of their ancestry [and race and sex] are by their very nature odious to a free people whose institutions are founded upon the doctrine of equality." *Id.* at 208 (citation omitted). Accordingly, "[a]ny exception to the Constitution's demand for equal protection must survive a daunting two-step examination known ... as strict scrutiny." *Id.* at 184

(internal quotation marks and citation omitted). The scholarships at issue here flunk that exacting test.

Under strict scrutiny, suspect classifications "are constitutional only if they are narrowly tailored measures that further compelling governmental interests." *Adarand Constructors v. Pena*, 515 U.S. 200, 227 (1995). It is the government that bears the burden to prove "that the reasons for any [racial] classification [are] clearly identified and unquestionably legitimate." *Richmond v. J. A. Croson Co.*, 488 U.S. 469, 505 (1989). Here, URI cannot carry its burden.

A "racial classification, regardless of purported motivation, is presumptively invalid and can be upheld only upon an extraordinary justification." *Shaw v. Reno*, 509 U.S. 630, 643-44 (1993) (citation omitted). Here, URI cannot demonstrate that restricting scholarships on the basis of race, color, national origin or sex serves any legitimate governmental purpose, let alone an extraordinary one. Classifications based on immutable characteristics "are so seldom relevant to the achievement of any legitimate state interest" that government policies "grounded in such considerations are deemed to reflect prejudice and antipathy – a view that those in the burdened class are not as worthy or deserving as others." *City of Cleburne v. Cleburne Living Ctr.*, 473 U.S. 432, 440 (1985).

Indeed, the Supreme Court has recognized only two interests compelling enough to justify racial classifications. The first is remedying the effects of past *de jure* segregation or discrimination in the specific industry and locality at issue in which the government played a role, and the second is "avoiding imminent and serious risks to human safety in prisons, such as a race riot." *Students for Fair Admissions*, 600 U.S. at 207 (citation omitted). ¹³ Neither applies here.

If the scholarships are intended to achieve racial balance, such an objective has been "repeatedly condemned as illegitimate" and "patently unconstitutional" by the Supreme Court. *Parents Involved in Cmty. Sch.*, 551 U.S. at 726, 730 ("Accepting racial balancing as a compelling state interest would justify the imposition of racial proportionality throughout American society, contrary to our repeated recognition that at the heart of the Constitution's guarantee of equal protection lies the simple command that the Government must treat citizens as individuals, not as simply components of a racial, religious, sexual or national class") (cleaned up, citation omitted).

And, irrespective of whether conditioning eligibility for the scholarships on immutable characteristics furthers a compelling interest, those classifications are not narrowly tailored. *Grutter v. Bollinger*, 539 U.S. 306, 334 (2003) (to be to be narrowly tailored, a race-conscious

program must be based on "individualized consideration," and race must be used in a "nonmechanical way"). Here, the race- and sex-based criteria are blanketly applied.

Further, a policy is not narrowly tailored if it is either overbroad or underinclusive in its use of racial classifications. *J.A. Croson Co.*, 488 U.S. at 506. Indeed, in *Students for Fair Admissions*, the Supreme Court found that similar categories as those used to determine eligibility for URI's scholarships were "imprecise," "plainly overbroad," "arbitrary," "undefined" and "opaque," 600 U.S. at 216-17, ¹⁴ and declared that "it is far from evident ... how assigning students to these ... categories and making admissions decisions based on them furthers the educational benefits that the universities claim to pursue." *Id.* at 216.

Similarly, restrictions that limit students from participating in school-administered scholarships due to race or sex are underinclusive since they are arbitrary and exclude swaths of students who would otherwise qualify. Although sex-based discrimination is subject to a "heightened" standard of review, *Sessions v. Morales-Santana*, 582 U.S. 47, 57 (2017); *United States v. Virginia*, 518 U.S. 515, 532-34 (1996), it is less exacting than the strict scrutiny standard applicable to race-based classifications. Under Supreme Court precedent, sex-based classifications by the government require an "exceedingly persuasive justification." *Virginia*, 518 U.S. at 531. To make this showing, the government must demonstrate "at least that the [challenged] classification serves important governmental objectives and that the discriminatory means employed are substantially related to the achievement of those objectives." *Id.* at 533. The scholarships identified in this complaint fall short of satisfying this standard for the same reasons they fail strict scrutiny.

Finally, for a policy to survive narrow-tailoring analysis, the government must show "serious, good faith consideration of workable race-neutral alternatives," *Grutter*, 539 U.S. at 339, and that "no workable race-neutral alternative" would achieve the purported compelling interest. *Fisher v. Univ. of Tex. at Austin*, 570 U.S. 297, 312 (2013). There is no evidence that any such alternatives were ever contemplated here.

URI's explicit racial and sex-based scholarships are presumptively invalid, and since there is no compelling government justification for such invidious discrimination, URI's offering, promotion, and administration of these programs violates state and federal civil rights statutes and constitutional equal protection guarantees.

OCR Has Jurisdiction

URI is a public entity and a recipient of federal funds, ¹⁵ including from the U.S. Department of Education. ¹⁶ It is therefore liable for violating Title VI, Title IX and the Equal Protection Clause, and OCR therefore has jurisdiction over this complaint.

The Complaint Is Timely

This complaint is timely brought because it includes allegations of discrimination based on race, color, national origin and sex that occurred within 180 days and that appear to be ongoing. The application period for each of the scholarships listed above for the 2024-2025 academic year ended within the last 180 days. Further, the FAQ for the URI online scholarship system provides that the application for the scholarships listed above "runs April through June each year," and that "[t]he system will reopen for the next scholarship season in the spring semester."¹⁷

Request For Investigation And Enforcement

In *Richmond v. J. A. Croson Co.*, Justice Scalia aptly noted that "discrimination on the basis of race is illegal, immoral, unconstitutional, inherently wrong and destructive of a democratic society." 488 U.S. at 505 (citation omitted). This is true regardless of which race suffers – discrimination against white applicants is just as unlawful as discrimination against black or other non-white applicants. As Justice Thomas correctly noted in *Students for Fair Admissions*, racebased admissions preferences "fly in the face of our colorblind Constitution and our Nation's equality ideal" and "are plainly – and boldly – unconstitutional." 600 U.S. at 287 (Thomas, J., concurring).

Because the discrimination outlined above is presumptively illegal, and since URI cannot show any compelling government justification for it, the fact that it conditions eligibility for multiple scholarships on race, color, national origin and sex violates federal civil rights statutes and constitutional equal protection guarantees.

The Office for Civil Rights has the power and obligation to investigate URI's role in creating, funding, promoting and administering these scholarships – and, given how many there are, to discern whether URI is engaging in such discrimination in its other activities – and to impose

whatever remedial relief is necessary to hold it accountable for that unlawful conduct. This includes, if necessary, imposing fines, initiating administrative proceedings to suspend or terminate federal financial assistance and referring the case to the Department of Justice for judicial proceedings to enforce the rights of the United States under federal law. After all, "[t]he way to stop discrimination ... is to stop discriminating[.]" *Parents Involved in Cmty. Sch.*, 551 U.S. at 748.

Indeed, URI appears to admit that there is a strong likelihood that several of its discriminatory scholarships are unlawful – because in its descriptions of such scholarships URI notes that "if such an award would not otherwise comply with applicable law, then the scholarship shall go to a student with demonstrated financial need and in good standing from a historically underrepresented population at the University." This reflects both a consciousness of guilt on the part of URI and a callous disregard for federal anti-discrimination laws and URI's constitutional obligations. This highlights the urgent need for OCR to conduct an investigation and put an end to this misconduct before the spring 2025 reapplication period begins.

Accordingly, we respectfully ask that the Department of Education's Office for Civil Rights prioritize and expedite this complaint given the sheer number of discriminatory scholarships at URI reflecting a systematic disregard for Titles VI and IX, promptly open a formal investigation, impose such remedial relief as the law permits for the benefit of those who have been illegally excluded from URI's various scholarships based on discriminatory criteria, and ensure that all ongoing and future scholarships and programming at URI comports with the Constitution and federal civil rights laws.
