**Re: Supplemental Evidentiary Submission in Support of Complaint –
Puente Project (09262228 & 09262229)**

Dear Assistant Secretary Richey and OCR Staff,

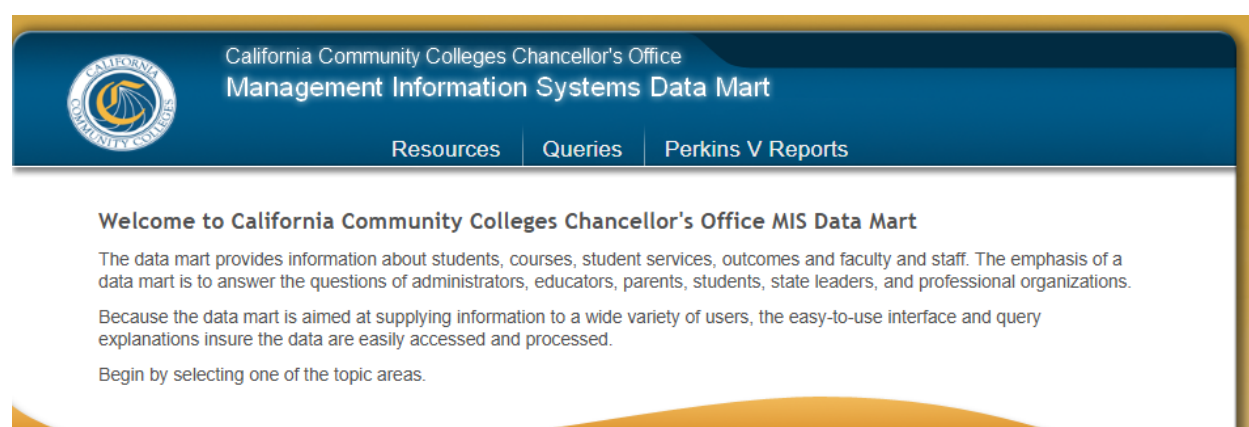
On January 18, 2026, the Equal Protection Project of the Legal Insurrection Foundation submitted a federal civil rights complaint pursuant to the U.S. Department of Education's Office for Civil Rights ("OCR") discrimination complaint resolution procedures,¹ concerning California's "Puente Project." On January 28, 2026, OCR assigned Case Number **09262228** to EPP's allegations concerning the University of California Office of the President, and Case Number **09262229** to EPP's allegations concerning the California Community College Chancellor's Office.

While we included evidence showing discrimination against non-Hispanic/Latinx students at individual colleges we believed was reflective of the overall statewide trends at the

time we submitted our complaint,² we did not possess or include specific statewide data showing this discrimination was present at the statewide level across the Puente Project. We now possess that statewide data, which shows that **the vast majority of Puente Project participants have been and remain Hispanic/Latinx**. Therefore, we respectfully submit this statewide data in support of our complaint and OCR’s investigation regarding the Puente Project.

The California Community College Chancellor’s Office’s website provides a Data Mart which includes searchable information “about students, courses, student services, outcomes and faculty and staff.”³



Under the “Queries” tab, you can open the search function for “Student/Headcounts.”⁴

→ Students/Headcounts

- **Student Annual/Term Count**
Student annual/term count and demographics.
- **Enrollment Status**
Student demographics and enrollment status information: first time, transferred from another institution of higher education, returning, continuing, special admit (currently enrolled in K-12), or unreported/uncollected.
- **Special Population/Group Student Count**
Special population/group student count and demographics.
- **Day/Evening Status**
Student demographics and day/evening status by whether the class is offered during the day, the evening, or the class time offered is unknown (i.e. to be arranged or independent study).
- **Part-time/Full-time (Unit Load)**
Student demographics by the number of units that a student attempted during the term.
- **Citizenship Status Summary**
Student demographics and citizenship status information: U.S. Citizens, Permanent Resident, Student Visa, etc.
- **Education Status Summary**
Student demographics and education status information: Special Admit, College Degree, High School Graduate etc.
- **Fulltime Equivalent Students (FTES)**
Credit and Non-Credit FTES count.
- **Distance Education (DE) Fulltime Equivalent Students (FTES)**
Distance Education (DE) and Non-DE Credit and Non-Credit FTES count.

From this page, you can navigate to the “Special Population/Group Student Count” tab.⁵ On this search page, you can then enter “Puente” under the “Select Program/Special Population” tab, “Select all” for the term, and click the “Ethnicity” on the bottom to include demographics in the report.⁶

After running the report, the statewide demographic numbers are provided for Puente Project participants from the present back to 2011.⁷ While the exported complete dataset as downloaded from the Chancellor’s Office’s Data Mart can be accessed at the included link,⁸ below are specific data on the percentage of students statewide from the past five years who were Hispanic/Latinx:

- 2020:
 - Spring: 92.80%
 - Summer: 94.74%
 - Fall: 92.70%
 - Winter: 92.27%

 - Spring: 92.16%
 - Summer: 91.58%
 - Fall: 91.92%
 - Winter: 97.80%
- 2022
 - Spring: 92.94%
 - Summer: 92.99%
 - Fall: 93.81%
 - Winter: 88.27%
- 2023
 - Spring: 93.17%
 - Summer: 93.84%
 - Fall: 92.85%
 - Winter: 95.09%
- 2024
 - Spring: 93.45%
 - Summer: 94.03%
 - Fall: 92.95%
 - Winter: 91.42%

As noted, these data show that the vast majority of Puente Project participants have been and remain Hispanic/Latinx. Accordingly, we respectfully request that the Department of Education's Office for Civil Rights consider this data as part of its investigation of the Puente Project's legality and constitutionality pursuant to EPP's complaint.
